Concerns shared with State in Quality Review Meetings

- Daily notes not being visible in parent portal
- Lack of the functions in EI Hub
 - Agencies had to increase cost for support staff (additional hires and additional hours)
- Unable to complete progress reports in EI Hub
- Agencies have to pay for an additional cost for outside systems to complete mandated documentation
- Agencies and providers are using 4 to 5 different systems in order to communicate and complete paperwork that state requires
- Thursdays EIHub maintenance is too early. Some of our providers are still working and are not able to complete daily notes – **THIS HAS BEEN CHANGED**
