

## **Developmental Disabilities Overview Executive Summary**

### **National Overall Trends:**

- Estimated Incident Rate of I/DD is 1.5% of Population
- Estimated 4.7 million persons with I/DD
- The number of people with I/DD receiving LTSS increased from 1.1 million (24% of total estimated I/DD population) to 1.3 million (28% of total estimated I/DD population).

### **Indiana Overall Trends:**

- Estimated 100,000 persons with I/DD
- The number of people with I/DD receiving LTSS increased from 25,734 (26% of population) to 36,000 (36% of population).
- The number of residents with I/DD waiting for HCBS waiver remained steady at 1,400.

### **Federal Match:**

- The Federal match ratio for Waivers, ICF Group Homes, and nursing homes decreased from 67% federal, 33% state to 66% federal, 34% state.

### **State Developmental Centers:**

- US: the number of individuals with I/DD in State Developmental Centers decreased from 30,000 (3%) to 21,000 (2%).
- Indiana has 0 persons in State Developmental Centers.

### **Nursing Homes:**

- US: the number of persons living in nursing homes decreased from 28,000 to 27,000, continuing to represent 2% of the total population
- Indiana: the number of individuals in nursing homes stayed constant at 1,400.

### **Private Intermediate Care Facilities:**

- US: the number of people in Private Intermediate Care Facilities decreased from 55,000 (5%) to 52,000 (4%).
- Indiana: the number of individuals in private intermediate care facilities decreased from 3,600 (14%) to 3,400 (10%).

### **Living with Family in Home Receiving HCBS Waiver Services:**

- US: the number of persons living with their families receiving an HCBS waiver increased from 635,000 (56%) to 699,000 (52%).
- Indiana: the number of people living with their families while receiving an HCBS waiver increased from 13,619 (53%) to 24,000 (67%) in Indiana.

### **Live with Host Family in their Home Receiving HCBS Waiver:**

- US: the number of persons living with a host family and receiving HCBS Waiver services increased from 59,000 to 62,000, continuing to represent 5% of the total population.
- Indiana: the number of people living with a host family and receiving HCBS Waiver services decreased from 259 (1%) to 180 (0%).

### **Group Waiver Setting with 1-3 Housemates:**

- US: the number of individuals living in a Group Waiver setting with 1-3 housemates increased from 207,000 (18%) to 330,000 (25%).
- Indiana: the number of individuals living in a Group Waiver setting with 1-3 housemates decreased from 6,606 (26%) to 6,400 (18%).

### **Live in Own Home that they own:**

- US: The number of persons with I/DD that live in their own home that they own increased from 123,000 (11%) to 140,000 (10%).
- Indiana: The number of persons with I/DD that live in their own home stayed constant at 250, 1% of the state population.
