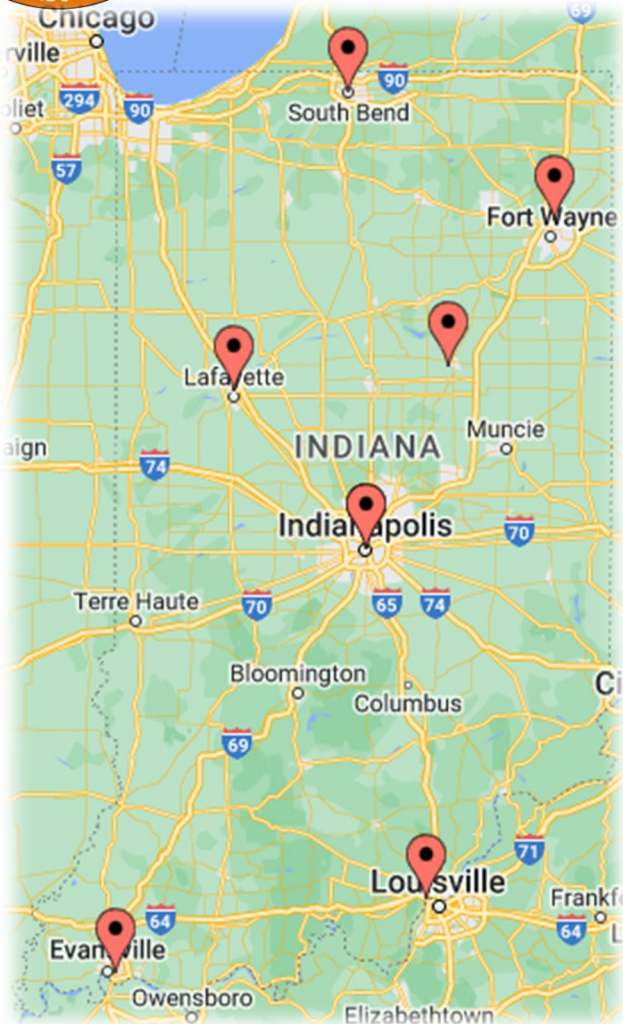

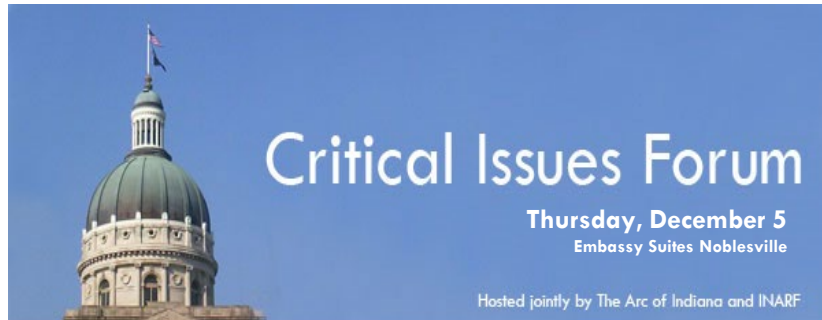

INARF Biennial Salary Survey

INARF Strategic Priority: Data Collection, Advocacy

- Launching August 9
- **New this Year: Free to Participating Members!**
 - Goal: increase engagement in the survey

IHCP Updates

- [BT2024110](#)
 - Temporary Emergency Financial Assistance Program for PathWays providers that experience a financial emergency as defined in law ([SEA 132](#)) due to PathWays claim payments issues. A provider is only eligible from the MCE in which the provider [successfully completed the PathWays claims testing process](#). If you are experiencing claim-processing challenges, contact the appropriate MCE provider relations contact.
- [BT2024108](#)
 - IHCP and Sandata identified and is addressing an issue preventing some EVV records for services submitted June 19, 2024 through July 8, 2024 from being accepted. The system was rejecting visit records for service codes that included multiple modifiers. Vendors will need to resubmit impact client visit data to Sandata if they receive the errors in the bulletin.



IHCP Updates

- [BT202455](#)
 - The Gainwell Technologies team will be moving their physical location, and along with this move, will also be changing their P.O. Box addresses
 - Effective August 1, 2024, all correspondence should be directed to the appropriate P.O. Box.
 - Prior mail addresses will remain available until stakeholders have had ample time to accommodate this change.



Pre-Voc Certification Update

- According to the DDRS Waiver Manual, Pre-voc must have one of the following accreditations:
- Must obtain/maintain accreditation (specific to Indiana programs) by at least one of the following organizations:
 - The Commission on Accreditation of Rehabilitation Facilities (CARF), or its successor
 - The Council on Quality and Leadership In Supports for People with Disabilities, or its successor
 - The Joint Commission on Accreditation of Healthcare Organizations (JCAHO), or its successor
 - The National Committee for Quality Assurance, or its successor – The ISO-9001 human services quality assurance (QA) system (No distinction between ISO-9001 and ISO-9001 human services quality assurance (QA) system)
 - An independent national accreditation organization approved by the FSSA Secretary



PathWays/H&W Waitlist

- No waitlist for the overall PathWays program - **only individuals eligible for waiver services under PathWays may be placed on a waitlist.**
 - As of July 1st - 9,015 people are on the waitlist for PathWays Waiver and 3,762 are on the waiting list for the Health and Wellness Waiver

HCSP Training Initiative

- [Syra Health Corp.](#) Was awarded an initial 4-year contract to provide HCSP Training Services for the state of Indiana.
 - [SEA 309](#) requires the division to consult with stakeholders and establish a tiered training certification program for direct support professionals.
 - Part of the [Indiana Direct Service Workforce Plan](#) to provide standardized foundational training to DSP's throughout the state.
 - Registry for DSP's will be housed here in the future as well.
