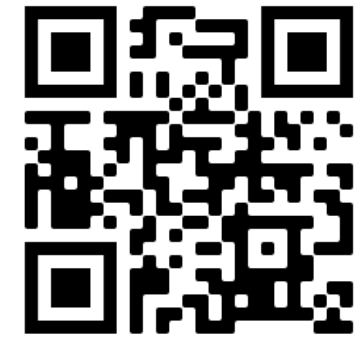

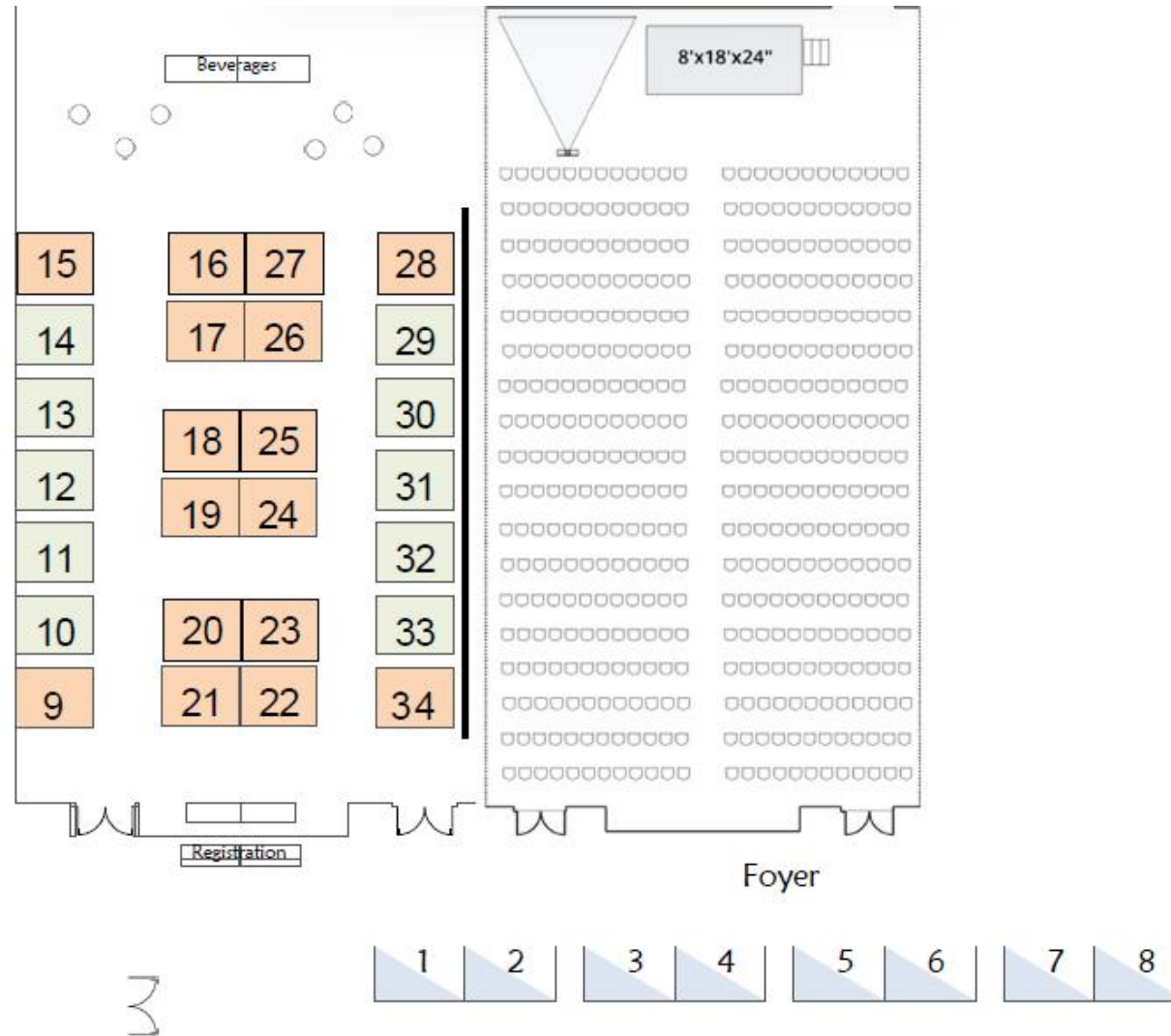

- The Indiana Family and Social Services Administration is transitioning to Salesforce Marketing Cloud for all agency email updates on Jan. 1, 2025. Future news releases, stakeholder announcements, newsletters, etc. will be sent out via Marketing Cloud. Please add fssa@subscription.in.gov

- **Medicaid Advertising**

- FSSA is ending their marketing and advertising efforts for HIP
- This does not impact Medicaid Waivers
- Related to Senate Bill 2

- **Health and Family Services Dashboard:** Directs the Indiana Family and Social Services Administration (FSSA) to develop an interactive dashboard to streamline healthcare programs, reduce redundancy, and improve the quality and cost of care for Hoosiers.
- **Assessing Waste, Fraud, and Abuse:** Directs the Indiana Family and Social Services Administration (FSSA) and the State Personnel Department (SPD) to conduct independent audits of healthcare expenditures in Medicaid and the State Employee Health Plan respectively, and report findings in order to root out inefficiencies and misuse of taxpayer dollars.

- **Improve Price Transparency:** Directs state agencies to enhance price transparency across healthcare services, empowering Hoosiers with clear, upfront pricing to make informed decisions.
- **Enforcing Budget Discipline:** Directs the Office of Management and Budget (OMB) to conduct regular reviews of budgeting practices, agency oversight and analysis, measure performance of government activities, and enforce a balanced budget for the biennium.
- **Reducing Regulation and Controlling Regulatory Costs:** Requires agencies to do thorough review of current rules and new rules related to cost of implementation among other factors.

DSP Training Platform

- DSP Training Platform will be available to Providers July 1, 2025
- Beginning January 1, 2026, DSPs will be required to participate in the mandatory training in order to be a DSP
- DDRS will be coming to present on the progress of platform at the February 28 INARF Member Forum and the April 25 INARF Member Forum
- Many issues and questions are still outstanding on the implementation of this new platform
- DDRS requests that Providers [respond to a survey](#), distributed by DDRS vendor Syra Health

- According to the IHCP bulletin [BT2024170](#) and subsequent communication, the attending provider listed on claims must always be an individual person enrolled with the Indiana Health Coverage Programs (IHCP) as either an ordering, prescribing, or referring (OPR) provider or a rendering provider on the date of the first service provided. Claims using a group or billing provider's NPI are denying with EOB code 1142.
- **We are working on this issue with the state towards a resolution that makes sense for ICF providers.**

- Introduces the Level of Care Assessment Representative (LCAR) contractor for enhanced evaluation and oversight responsibilities
- Transitioned from using the e-screen to the InterRAI suite of instruments for level of care evaluations and re-evaluations
- HHAs are continued to be reimbursed for providing skilled respite services under the waiver

- Participant-Directed Attendant Care Service
 - Participants choose, schedule, train, supervise, and dismiss their own personal attendants
 - Participants assume employer responsibilities, except for payroll management
 - Available only to participants who do not live in congregate settings
- Participant-Directed Home Care Service
 - A caregiver reimbursement budget is developed based on an FSSA Algorithm
 - Only available to participants residing in their own private residence

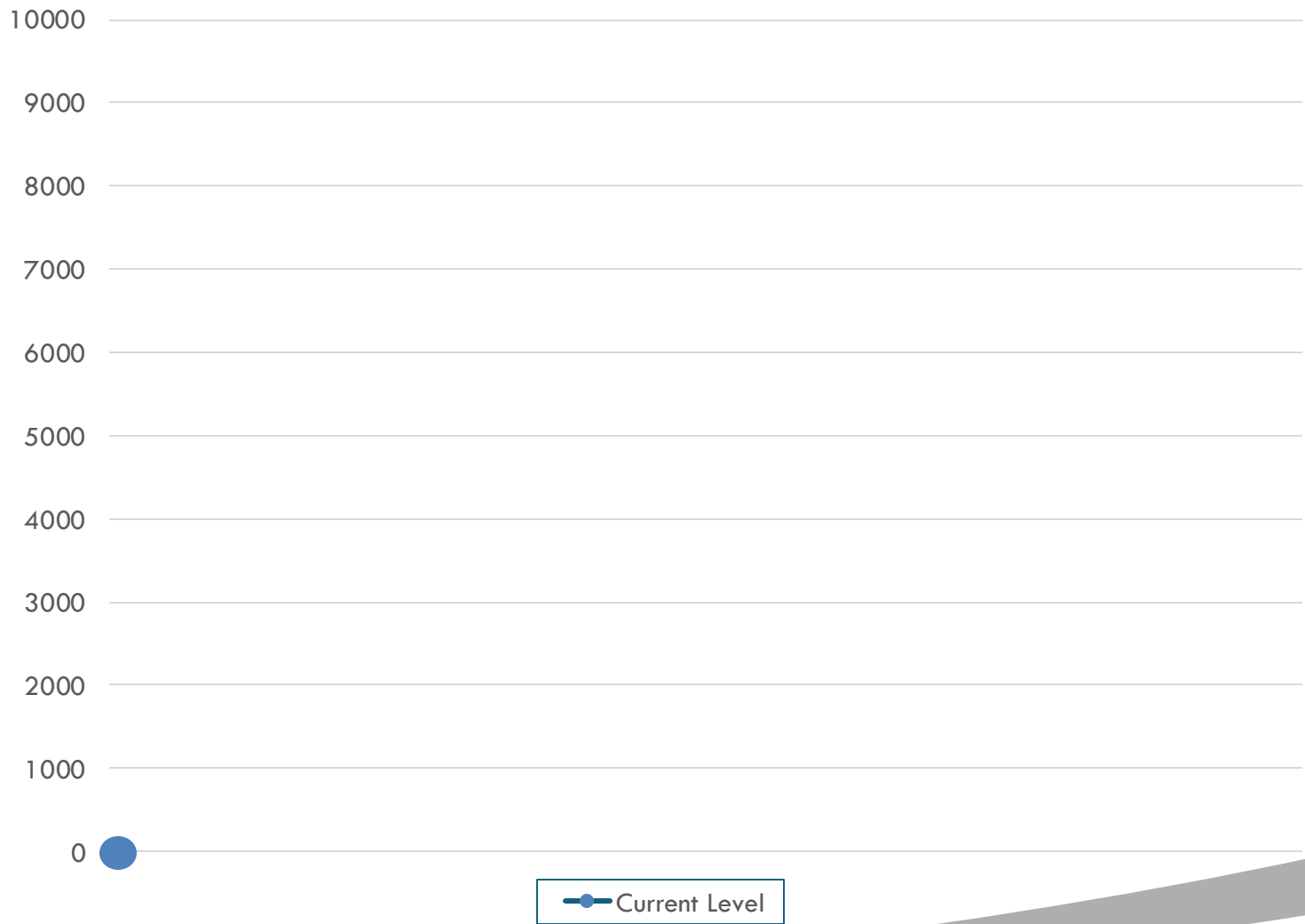

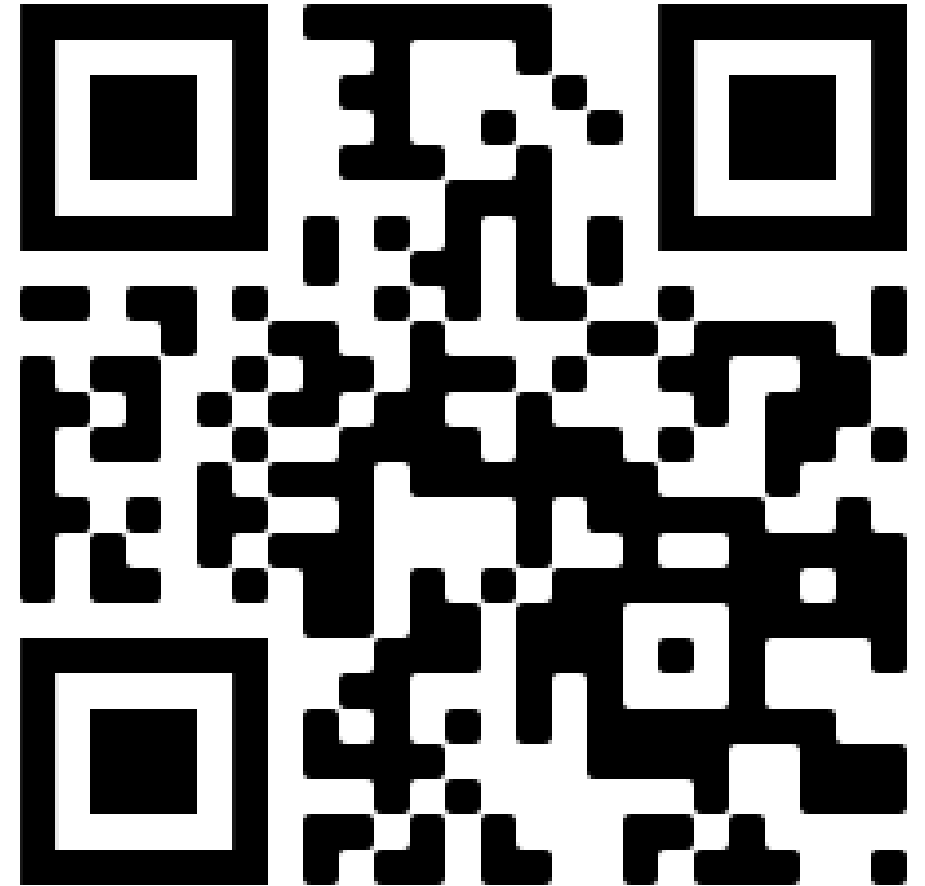
